IIJ to Increase Data Volumes and Provide Additional SIM Cards in the IIJmio High-Speed Mobile/D Service

--increases the data volume of the Light Start Plan from 5GB to 6GB, allows up to two SIM cards for the Minimum Start and Light Start Plans--

Details: The handling fee for adding SIM cards (JPY2,000 per card, before tax) will be discounted by JPY1,000.
